Cost: \$9 NRA fee (Includes NRA Shooting fee and Registration fee), plus \$6 NYSRPA fee, plus \$10 per event. Team events are \$8 per team and will be “paper” teams. Make checks payable to: DCPA.

NOTE: Many requested that we add air pistol and rapid fire to our one-day program. Due to range availability and schedule, **it is not possible for shooters to shoot all 5 guns in one day**. Therefore, a four-gun package is offered at **\$50**, which includes registration and NYSRPA fees.

*Single target carriers are not available. Range does not comply with NRA Rule 5.3 due to permanent structure. Infiltration takes place as openings become available. If bad weather, DCPA reserves the right to cancel or modify the outdoor air pistol competition.

+ Squading is first-come first served. Competitors **will not** have to fire the 1st-half before firing the 2nd-half.

+NOTE: THE TIME HAS CHANGED AND WILL BE SHOT ON RANGE 2 AFTER AIR PISTOL.

Class & Category: All competitors must register using their appropriate classification under NRA Shooting classification system. An open winner in each event. If fewer than 4 entries in a category, categories will be combined within the same class. If fewer than 4 entries in a class, competitors will be moved to their respective categories in the next higher class. Unclassified shooters will be assigned classifications according to NRA Rule 19.6.

Awards: Cash or NRA points. NYSRPA WILL AWARD PRIZES FOR STATE CHAMPIONS.

Eligibility: This match is a NRA sanctioned match. **To be eligible for NY State awards, all shooters must belong to the NYSRPA or their home state organization. Membership cards must be presented at the time of registration. Each competitor will be required to fill out and sign the “Competitor Fact Sheet” to be sent to the NYSRPA Pistol Director. NRA and NYSRPA membership applications will be available at the range.**

General Rules: Competitors must be individual members of the NRA. NRA International Pistol Rules and classification system will be used. NRA Pistol Rule 3 regarding firearms, equipment, and ammunition will be adhered to. Competitors failing to present themselves at their proper relay lose the right to compete in that match. Scoring will be after each 10 shot string. Plug-type scoring gauge use is restricted to range and executive officers, jury, or NRA Referee who will plug for shot values in or out of the scoring ring. A challenge fee of \$1.00 must accompany the target. Smoking and alcoholic beverage consumption is forbidden while the match is in progress. DCPA will exclude anyone not conducting himself or herself in a proper manner.

Location: From I-84 use Exit #13, US Route 9 North. Proceed 6 miles. Turn right onto New Hackensack Road (County Route 104). Go 2 miles. Turn right onto St. Nicolas Road. Go approximately one mile. DCPA is located on the left. Range phone number is (845) 297-4481 if you need help finding us.
